Data Privacy Statement

All personal data is dealt with in compliance with EU Regulation No. 2016/679 (GDPR) for the purposes of a) the application for the Winter School on Federalism and Governance 2022, and b) the receiving of newsletters and emails informing the recipient on the activities of the Institute for Comparative Federalism (i.e. calls, invitations, publications).

The legal basis for the processing of your personal data is your consent to the processing of your personal data. Personal data will be stored for a) 24 months after the application deadline and b) as long as the newsletter service is available or you remain subscribed to it and, in any case, the time required to comply with the Applicable Law (art. 2649-2647 c.c.). When this period has been reached, the data shall be deleted or made anonymous.
